Breeding Contract

This stallion breeding contract for the 2009 breeding season is made and entered into on this day of _____ 2009, by and between Debbie Kinney , Breeder and the hereinafter designated mare owner_____.Mare Owner agrees to breed mare_____, registration # _____ to the Stallion JBS MrUltimateImprint Registration # 502-259,for the fee of \$500.00 subject to the following conditions:

1. The stallion fee includes \$250.00 non-refundable booking fee,payable upon execution of this contract. The balance of this fee must be paid , with any other expenses incurred, including all vet work., when mare is pick up. Shipped semen fees will be paid prior to shipping. The shipping fee for 2008 is \$350.00 . This is regular shipping , if any extra fee accrue for special cirumstances they will be attached .(Same day , any out of country fees etc.)
2. Mare owner agrees to pay for mare care at \$20.00 per day for dry mares, \$25.00 per day for wet mares.
3. Breeder agrees to diligently try to settle mare: however, if mare fails to settle for any reason, mare owner agrees to hold breeder blameless. Mare Owner agrees to give breeder ample opportunity to settle mare.
- 4.This contract contains a Live foal Guarantee. A live foal guarantee is described as a newborn foal which stands and nurses without assistance. If foal is born dead, there is return privilage for the 2010 season only if breeder is notified within 15 days with vet certificate. If after being pronounced "safe in foal", the mare should miscarry, abort,or prove barren , mare owner has the privilege to return breeding during 2009 season through 6/1/09,or following 2010 season.
5. This contract also contains color guarantee. If mare produces a solid colored foal, the mare can return to a one time breeding of 350.00. This does not include mare care , vet work or shipping.
- 6.Both parties agree that Rockin K Farm , the breeder, is not liable for death,sickness and /or accident including damages caused to the mare and /or foal unless caused by gross negligence or the breeder and the mare owner is not liable for death,sickness,and/or accident to stallion.

7. It is further agreed that should the stallion die, be sold by owner, or become unfit for service, prior to selling the mare, that 500.00 of the breeding fee will be refunded. If it has been paid in full, thereby canceling this contract. Or if the mare dies or becomes unfit to breed, the breeder has the option to either accept another mare or refund \$500.00 of the breeding fee, if it has been paid in full.

When mare owner and breeder, or breeder's agent sign this contract, it will then be binding by both parties, subject to the above terms and conditions.

Please send copy of mare papers along with signed contract to Rockin K Farm and keep a copy for your records. Also must enclose booking fee of \$250.00. All shipping fee must be paid before shipping. Major credit cards are excepted with 2.5 % attached.
